Hans proposed to approve April minutes. Randy seconded. Approved.

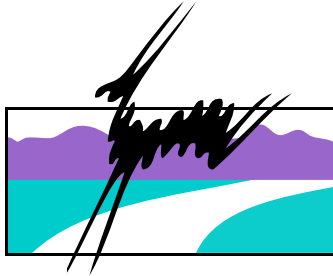
Treasurer's Report

Post Mortem on Quicksilver 50K/100K:

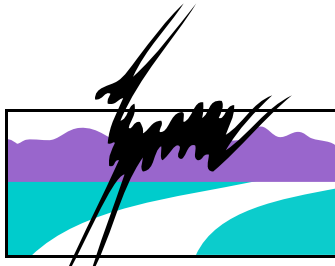
- Peggy said it went well. QuickSilver said “thanks so much”
