- Approval of July meeting minutes seconded and approved
- Financial overview


o **ACTION:** Budget for plates and cups, buy OWNER: Alison

- What is the budget for the venue? We have enough money
- ACTION: Look into Pichetti, other wineries, look into restaurant next to Hobees, community centers, wine room in Palo Alto OWNER: Hema/Alison
- What are the rules for selection for Western States drawing needs to be done ahead of time, typically done the first Saturday in December
- Ticket cost is \$55, price of the location will be factored into this year's price
- ACTION: Mike Kreaden to place minutes on the website

 - ACTION: Contact lumber company for the clambake and get permit in person (Hema and Allison), CLOSED



 - The person doing the announcements should sign a waiver that day, hardcopy
 - ACTION: Make a release form OWNER: Hema

- ACTION: Mike to coordinate with Anne on foam rolling workshop
 - Anne is available, location is the issue, choose a Sunday
 - Date chosen: August 24th, Location is still up in the air
